### ELIGIBILITY

- This exhibition is open to all **current** AWS Associate Members. To become an Associate Member, see instructions in the next paragraph.
- Eligible media: watercolor, acrylic, casein, gouache, egg tempera
- Work must be water media on paper (Yupo is accepted) No other surfaces accepted.
- No collage, pastels, class work, digital images, any form of print or reproductions.
- Artist's original work only. No class work. No work done under supervision. No copies or likenesses of another artist's work including published source or reference work not attributable to the artist.
- **One entry** per artist.
- No work previously exhibited with the American Watercolor Society may be submitted
- Artists may not substitute another work for an accepted work.

### ENTRY PROCEDURE

Entries **MUST** be submitted online.

### TO SUBMIT YOUR ENTRY ONLINE:

- Go to the AWS web site ([www.americanwatercolorssociety.org](http://www.americanwatercolorssociety.org)) and click on the 2021 Associate Members Exhibition link on the main page.
- If you do not already have one, you must create an AWS online account. Online entries require a valid email address.
- If you submitted an entry to the AWS International Exhibition in the last seven years, online or not, you already have an AWS online account.
- **If you already have an account DO NOT create a new one.**

- Be sure to read and follow the instructions in the section, "*About Your Digital Image*" below.

## **ABOUT YOUR DIGITAL IMAGE:**

- Digital file must be in JPG format, file size up to 3.5MB.
- For best presentation, resolution should be 300 DPI.
- MINIMUM of 1800 pixels on the longer side.
- Image must be correctly oriented (vertical or horizontal).
- Show only the image, no frame or mat.
- No digital enhancement is allowed.
- Please do not place an obvious watermark over your image.
- File name must include the artist's name in this format: (smith\_jane.jpg)

## **SALES**

- All paintings will be considered for sale at the price set forth by the artist unless marked NFS (Not for Sale) or 0 (zero). Prices may not be changed or withdrawn once submitted.
- Any painting sold in the Exhibition is subject to a 35% donation to the AWS.

Entry is open to current AWS Associate Members. If you need to renew your membership please do so *before* submitting your entry.
